Today, the American Academy of Pediatric Dentistry (AAPD) endorses pulpotomy as a key strategy in managing deep caries in primary teeth, particularly when conventional direct restorations risk pulp exposure or when pulp necrosis is imminent. Yet, the availability and execution of pulpotomy vary dramatically across geographies, shaped by economics, regulation, and infrastructure. In high-income nations like the United States, Canada, and much of Western Europe, pulpotomy is integrated into routine pediatric dental protocols. Dental schools train specialists in regenerative techniques, and insurance frameworks—though uneven—support access. A 2022 study in the *Journal of Pediatric Dentistry* reported that over 60% of U.S. pediatric dental practices routinely perform pulpotomies on primary teeth with irreversible pulpitis, citing reduced need for pulpectomies and long-term tooth retention. In contrast, low- and middle-income countries (LMICs) face systemic barriers. The pulpotomy, a technically precise but relatively low-tech intervention, becomes a litmus test for systemic access—revealing not just clinical capability, but political will. Debates persist over whether pulpotomy should be used prophylactically in deep caries or reserved for confirmed irreversible pulpitis, especially in young children with developing immune systems. Some researchers caution against overuse, warning that unnecessary procedures may increase patient anxiety and procedural fatigue. India's Ayushman Bharat program includes dental benefits but struggles with referral bottlenecks and uneven dentist density—especially in tribal regions. These variations underscore that pulpotomy's impact is not purely clinical, but deeply contingent on governance, funding, and cultural attitudes toward oral health. Looking forward, technological innovation and policy reform offer pathways to transformation. Digital imaging, intraoral scanners, and AI-assisted diagnostics are democratizing precision, enabling earlier, more accurate pulp assessments even in low-resource clinics. Tele-dentistry pilots in rural Kenya and Mexico show promise in bridging specialist gaps, allowing remote consultation on pulpotomy candidacy and post-op care.
