The Origins: From Manuscript to Mass Visual Culture The *Genji monogatari*, compiled by Murasaki Shikibu circa 1010–1020, emerged from the refined intellectual world of the Heian court (794–1185), a period marked by aristocratic refinement, Buddhist introspection, and the crystallization of Japanese literary language.
