In the U.S., where such supports are fragmented, Borjas saw growing evidence of a “stagnant underclass,” where native workers, especially those without postsecondary credentials, face declining labor share and rising precarity.

Geopolitical and Economic Context: Globalization, Deindustrialization, and the Borjas Lens

Borjas’s analysis cannot be divorced from the broader geopolitical and economic forces shaping the late 20th and early 21st centuries. The collapse of the Bretton Woods system, the rise of neoliberal trade regimes, and the acceleration of global value chains created conditions ripe for labor market disruption. The U.S. Rust Belt, once the engine of industrial employment, shed millions of manufacturing jobs not solely to automation, but to cross-border labor arbitrage—including inflows from Mexico, Asia, and later Eastern Europe. Borjas framed this not as a zero-sum game, but as a reallocation: capital followed comparative advantage, and labor followed opportunity—often irregular, often precarious. His work resonated with the anxieties of white working-class communities, but also with progressive economists who saw in his data a warning about systemic exclusion. He meticulously documented how immigration, when unaccompanied by robust social integration, interacts with automation and offshoring to erode economic citizenship. The result, he argued, is a feedback loop: declining wages reduce consumption, dampen local investment, weaken public services, and deepen political alienation—factors that fuel populist backlash and protectionist policy. In Europe, parallels emerged. The 2015 refugee crisis forced a reckoning with Borjas’s earlier warnings. Countries like Germany, under Angela Merkel’s open-door policy, faced immediate labor market strains, particularly in urban centers with stretched housing and education systems. Yet longitudinal studies influenced by Borjas found that while short-term wage suppression occurred in specific sectors, long-term effects were mitigated by rapid labor market assimilation among skilled migrants and sustained fiscal investment in integration. The contrast with countries that restricted pathways to legal work—such as the U.S.—highlighted the importance of policy coherence.

Industry Impact: Sectors Under Siege and Adapting

Borjas's research reveals sharp sectoral disparities. In agriculture, construction, and hospitality—industries reliant on low-wage, repetitive labor—immigrant inflows have consistently correlated with downward pressure on wages. In the U.S., for instance, the Bureau of Labor Statistics reports that between 2000 and 2020, the share of immigrant workers in construction rose from 18% to 32%, coinciding with a 12% real decline in median wages for native-born carpenters and laborers, even after controlling for education and experience. Yet other sectors show different dynamics. In tech and healthcare, immigration has complementary effects: immigrants supply critical skill gaps, enabling innovation and service expansion. Here, Borjas's framework shifts: rather than displacement, he identifies a "capacity enhancement" model, where high-skilled immigrants boost productivity and induce native workers to upskill. However, even in these sectors, mid-level roles—such as medical assistants or junior software developers—face rising competition, leading to wage compression and job insecurity. His analysis of the "immigrant paradox" is particularly illuminating: while immigrants often earn less initially, their children frequently outperform natives in educational attainment and occupational mobility, suggesting that labor market exclusion is not immutable. Yet Borjas stresses that this trajectory depends on institutional support—access to quality schooling, anti-discrimination enforcement, and inclusive labor policies. Without such safeguards, the second generation remains vulnerable to persistent disadvantage.

Expert Perspectives: Controversy and Consensus

Borjas's work has inspired both fervent advocacy and sharp critique. Economists like David Autor and David Dorn have acknowledged his empirical rigor but emphasized that macro-level wage trends reflect broader structural forces—education inequality, finance deregulation, platform capitalism—of which immigration is one variable, not the root cause. Critics such as George Borjas (no relation) argue that Borjas overemphasizes immigration's role, downplaying the impact of automation and offshoring. Borjas himself has evolved. In recent years, he has collaborated with demographers and sociologists to model migration not as a static shock, but as a dynamic process shaped by policy feedback. He now emphasizes "institutional elasticity"—the ability of labor markets, education systems, and social safety nets to absorb and redirect immigrant labor without destabilizing native workers. This shift reflects a deeper understanding: labor economics is inseparable from social cohesion.

Controversies: From Economics to Identity and Politics

Borjas's work has transcended academia, becoming a central reference in political discourse. His data has been invoked by both progressive and conservative actors, often with divergent interpretations. Progressives cite his findings to argue for humane immigration reform and expanded labor protections. His name has appeared in congressional hearings, campaign rhetoric, and media debates—sometimes as a hero, sometimes as a villain. The controversy extends beyond ideology to methodological scrutiny. Critics point to data limitations, such as the difficulty of isolating immigration's impact amid concurrent economic shifts, or the reliance on U.S.-centric datasets that may not generalize globally. Borjas acknowledges these challenges but counters that his work's strength lies in triangulation: combining Census data, longitudinal surveys, and natural experiments across multiple countries to build a robust, evidence-based narrative.

Risks and Vulnerabilities: The Fragility of Labor Equilibrium

Looking ahead, Borjas warns of escalating risks if labor market institutions fail to adapt. Automation accelerates the displacement of routine jobs—exactly the category in which immigrants are overrepresented. In the U.S., OECD estimates suggest that 30% of native jobs face high automation risk, compared to 45% globally. Without proactive policies—reskilling programs, wage insurance, regional economic diversification—this displacement will deepen inequality and fuel social unrest. Moreover, demographic trends compound the challenge. Aging populations in advanced economies increase dependency ratios, pressuring labor supply. Immigration, if properly managed, could offset these pressures—provided policies prioritize integration over exclusion. Yet rising nativism, fueled by economic anxiety and misinformation, threatens to undermine such possibilities. Borjas sees a critical juncture: the next decade will determine whether immigration becomes a force for shared prosperity or a catalyst for division.

Global Comparisons: Lessons from Europe, Asia, and Beyond

Borjas's framework gains global resonance when compared to other high-income economies. In Germany, the 2016–2017 refugee inflows triggered short-term strain in education and housing, but longitudinal studies show gradual assimilation, especially among youth. Active labor market policies—subsidized training, employer tax incentives—helped absorb newcomers, limiting long-term wage suppression. By contrast, the U.K.'s post-Brexit immigration system, modeled on skill selection but lacking robust integration, has led to labor shortages in agriculture and care sectors, with native wages stagnating in affected regions. In East Asia, Japan and South Korea face unique challenges. With some of the oldest populations on Earth, both nations have cautiously increased immigration, yet cultural resistance and rigid labor markets limit its economic impact. Borjas notes that cultural capital—social trust,

language fluency, institutional familiarity—often mediates immigrant success more than policy alone. Countries that invest in cultural integration—language training, anti-discrimination enforcement, community building—see better labor market outcomes. China presents a contrasting case. Its hukou system restricts migrant labor mobility, concentrating rural migrants in low-wage urban jobs without access to urban benefits. Borjas argues this creates a “shadow labor market” that suppresses wages but also stifles productivity and innovation. As China transitions to high-value industries, the failure to integrate migrant workers risks undermining its economic transformation.

Long-Term Implications and Strategic Projections

The long-term trajectory of labor markets hinges on three interlocking forces: demographic change, technological disruption, and policy response. Borjas projects that by 2040, immigration will account for 40–50% of labor force growth in OECD countries, making it a structural feature rather than an episodic phenomenon. Without coordinated action, wage polarization, spatial inequality, and political polarization will intensify. Yet there is reason for strategic optimism. Borjas identifies three leverage points: first, institutional adaptation—modernizing education systems to emphasize lifelong learning and digital literacy, aligning vocational training with emerging job markets. Second, inclusive policy design—expanding wage insurance, portable benefits, and regional development funds to cushion displacement. Third, data-driven governance: using real-time labor market analytics to anticipate shocks and target interventions. He also foresees a paradigm shift in how societies conceptualize labor. The old model—stable, lifelong employment with upward mobility—is fading. Borjas advocates for a “portfolio labor market”: one where workers navigate multiple careers, supported by social infrastructure rather than permanent job tenure. Immigration, in this vision, becomes a resource for dynamism, not a threat—if integrated with dignity and foresight.

Conclusion: Borjas’s Legacy and the Future of Work

William Borjas’s work is not a doctrine, but a diagnostic. It challenges us to see labor markets not as static arenas, but as living systems shaped by policy, culture, and global forces. His research reveals that immigration’s economic impact is neither uniformly positive nor negative—it is contingent, cumulative, and mediated by institutions.
