This model, while enhancing state control and financial inclusion, has sparked global debate over data sovereignty and the weaponization of digital payment networks. As China expands the yuan's use in Belt and Road Initiative countries through digital banking corridors, it challenges the Western-dominated SWIFT system, fostering a bifurcated global payments landscape. Emerging economies present a more heterogeneous picture. Nations like India and Nigeria have embraced mobile-first banking as a vehicle for financial inclusion, leveraging platforms like UPI and Paga to connect hundreds of millions unbanked citizens. India's Aadhaar-linked digital identity system, integrated with banking infrastructure, has enabled near-universal account access, yet raised alarms about data privacy and algorithmic bias. Nigeria's fintech boom—driven by platforms such as Flutterwave and Opay—has disrupted traditional banking, but regulatory gaps have led to recurring fraud incidents and liquidity squeezes. These tech-financial conglomerates, operating across payments, lending, wealth management, and identity verification, controlled vast data moats and transaction networks. Their systemic importance was profound: a single failure could ripple across multiple sectors. Yet, regulatory oversight lagged. The U.S. Securities and Exchange Commission (SEC) and OECD have called for new “core system resilience standards,” but progress remains slow. The financial cost of inaction was stark. In 2024 alone, global online banking losses exceeded \$15 billion, driven by phishing, account takeovers, and ransomware. The Maneb report projected that by 2030, unmitigated risks could push

annual losses to over \$50 billion—rivaling the scale of pre-2008 financial crises.
