The Skoll Foundation’s Social Enterprise Case Library (2015), for example, aggregated stories from microfinance, impact investing, and community health initiatives across Africa, South Asia, and Latin America. These cases were curated not just for educational value, but for replicability—highlighting lean, adaptive models suited to resource-constrained environments. Geopolitical dynamics shaped this diffusion. In Western economies, free case studies flourished as supplements to expensive textbooks, supported by university partnerships and public funding. In contrast, in post-Soviet states and fragile democracies, they often emerged from international NGOs and multilateral agencies—UNDP, OECD, ILO—intended to build local capacity. The African Development Bank’s “Case Studies

These localized efforts counter the historical dominance of Euro-American case frameworks, offering alternative paradigms for development. Yet they face challenges: limited international visibility, translation barriers, and uneven digital infrastructure limiting reach. The tension between universalism and specificity defines the debate. Critics argue that free case repositories, even when open, often prioritize Western corporate experiences—e.g., Silicon Valley tech scaling or Fortune 500 mergers—at the expense of non-Western innovation. A 2021 analysis by the African Management Institute revealed that only 12% of top-ranked open cases featured African founders or context-
