Dr. Rajiv Mehta, an expert in professional competency frameworks, notes: “Competence in ABA is not merely knowledge recall—it’s the integration of ethics, clinical judgment, and adaptive problem-solving under pressure. Rather than outright prohibition, some jurisdictions may adopt a hybrid model—certifying accredited providers while formally recognizing standardized, high-fidelity mock exams as preparatory milestones.
