Kenya, for example, introduced conditional licensing for mobile money platforms in 2018, requiring transaction volume thresholds and fraud detection KPIs as prerequisites for scale—conditions that spurred rapid adoption while curbing systemic risk. India followed suit in 2020, mandating “conditional sandbox” access for neobanks, with requirements tied to financial inclusion metrics rather than just solvency. These developments signaled a paradigm shift: regulation was no longer a static barrier but a dynamic partner in economic development.

The 2020s accelerated this trend. The European Union’s 2022 Markets in Crypto-Assets Regulation (MiCA) codified conditional statements into its crypto framework, allowing pilot programs for decentralized exchanges under strict data-sharing, investor protection, and anti-money laundering (AML) conditions. The U.S. Consumer Financial Protection Bureau (CFPB) expanded its use of conditional waivers in 2023, permitting fintechs to test cross-border payment systems with reduced reporting for three years—provided they achieved 95% transaction success rates and zero regulatory breaches. These moves reflected a global consensus: in fast-moving sectors, regulatory agility is not optional, but essential.

Geopolitical and Economic Context: Power, Policy, and the New Regulatory Geography

This conditional support accelerated financial inclusion but also required robust cross-border coordination with ASEAN regulators, revealing the tension between national policy autonomy and regional regulatory harmonization.

This has spurred calls for international coordination: the OECD’s Working Group on Conditional Regulatory Frameworks now proposes a “Conditional Treaty” model, akin to tax treaties, to harmonize core conditions across jurisdictions and prevent regulatory arbitrage.

Similarly, African neobanks like Flutterwave embedded conditional compliance into their core architecture, linking license renewals to verified transaction monitoring, fraud detection, and financial literacy KPIs—turning regulatory conditions into trust signals.
