The Missouri Compromise (1820), Compromise of 1850, and the Kansas-Nebraska Act (1854) were not merely legislative acts but flashpoints in a deeper struggle over slavery, states' rights, and the meaning of equality. The Civil War (1861–1865) resolved the immediate crisis, but Reconstruction's promise—enshrined in the 13th, 14th, and 15th Amendments—was systematically undermined by Southern resistance, Black Codes, and federal retreat.
