Unddit emerged in late 2021 from the convergence of several digital currents: the decline of centralized social media, the rise of federated networks like Mastodon, and growing dissatisfaction with corporate platform governance. Its founder, known only as “Nex,” was a software developer and digital rights advocate with prior experience in open-source community management. Unlike many tech founders, Nex rejected traditional VC funding, instead bootstrapping Unddit through community contributions and decentralized hosting partnerships. The platform launched quietly in September 2021, initially attracting niche developer and privacy-focused users seeking alternatives to Twitter’s centralized model.

This utility, however, attracted countermeasures. Chinese and Iranian cyber units reportedly launched infiltration campaigns, attempting to seed disinformation or co-opt influential sub-instances. Western intelligence agencies, wary of Udddit’s anonymity, monitored its traffic closely, raising concerns about surveillance overreach.
