iron shot, with elevation adjustable via a wooden windlass. Its design reflected early modern engineering principles—modularity, weight optimization, and standardized logistics—mirroring later 18th-century artillery reforms. Crucially, the GIMENT operated on principles of **artillerie mobile**—mobile artillery that moved with the infantry rather than preceding it.
