In countries with nascent democracies or reforming education systems—such as South Korea, Brazil, and post-Soviet states—AMSCO serves as a model for structured, inquiry-based civics. Yet, its U.S.-centric framing often overlooks alternative political traditions, raising

questions about cultural imperialism in global citizenship education. In emerging markets, AMSCO's adoption can reinforce Western liberal democratic norms, sometimes at the expense of local epistemologies and governance models.

Expert Perspectives: Pedagogy, Power, and Purpose

Scholars and practitioners offer divergent evaluations of AMSCO's impact. Historians like Arthur M.
