The cognitive science community, including researchers from MIT’s Medical Learning Initiative and the University of Oxford’s Centre for Medical Education, has contributed critical insights. Their work demonstrates that MCQs are effective when designed around spaced repetition, interleaved practice, and feedback loops—principles grounded in how human memory and expertise develop. They caution, however, against “overfitting” assessments to test-taking strategies rather than deep understanding. One study found that trainees who memorized MCQ patterns performed poorly on novel clinical scenarios, underscoring the need for assessments that reward conceptual fluency over rote recognition. Closely tied is the issue of psychological burden.
