This fiscal environment forced institutions like KEMU to rely increasingly on tuition revenue, student loans, and partnerships with private sector actors. The 2019 National Health Act amendment further empowered universities to set tuition fees, with oversight from the National Health Act Regulatory Committee (NHARC), but left implementation uneven. KEMU, as a semi-autonomous college within a state university system, navigated this ambiguity by aligning fees with cost-recovery principles, yet facing criticism for opacity in fee determination. Expert analysis reveals that the KEMU model reflects a broader African paradox: the push for professionalization amid chronic underinvestment. Dr. Adebayo Ogunlesi, a health economist at the University of Ibadan, notes: 'The fee structure is a double-edged sword. On one hand, it signals commitment to quality—by charging fees, institutions invest in facilities, trainers, and accreditation. On the other, it restricts access for a population where 60% lives below the poverty line. Nursing, intended as a ladder out of poverty, becomes a ladder with steep tolls.' This tension is compounded by Nigeria's brain drain: while KEMU trains thousands, many qualified nurses seek employment abroad, where fees for international nursing programs remain prohibitive but wages and working conditions often

Similarly, Rwanda’s post-genocide health reforms—centered on state-led nursing academies with controlled tuition and government stipends—offer a model where education aligns with national health goals. Nigeria’s KEMU structure, by contrast, remains caught between decentralized autonomy and centralized equity mandates, lacking the coherence of such integrated systems. Looking ahead, the long-term implications hinge on structural reforms. Experts advocate for a hybrid financing model: preserving tuition to ensure institutional sustainability, while expanding targeted scholarships, conditional cash transfers, and public-private partnerships. The 2024 National Health Workforce Strategy, currently under development, proposes a national fee cap tied to inflation and health sector benchmarks, accompanied by a centralized fee register. Globally, Nigeria's model aligns with low-income countries where health education is underfunded and tuition-based—contrasting with high-income systems like Germany's tuition-free public nursing programs. Yet unlike South Africa's National Health Service, which integrates fee revenue into a broader public health financing framework, KEMU operates largely in isolation, dependent on internal revenue and limited state subsidies, making its model fragile in times of economic stress.

Industry Impact: Workforce Supply, Equity, and Systemic Tensions

The KEMU Nursing Fee Structure directly shapes Nigeria's nursing workforce supply, with profound implications for access and equity. Public institution fees, though nominally subsidized, often exceed the means of eligible students, forcing reliance on loans, family support, or conditional cash transfers. While KEMU offers limited scholarships—primarily through state partnerships—its capacity remains marginal compared to demand: the Nigerian Nursing Council estimates a shortfall of over 50,000 trained nurses, yet only 12,000 enter formal practice annually. Fees thus act as both a gatekeeper and a filter, privileging those with financial safety nets while excluding marginalized groups. This dynamic fuels a two-tier system: trained nurses in urban centers command higher wages and better working conditions, while rural practitioners—often underpaid—face burnout and attrition. The 2021 KEMU strike, driven by fee increases and poor working conditions, exemplified these tensions, revealing how financial barriers undermine workforce stability. Without systemic reform—such as needs-based subsidies, regional fee differentials, or expanded loan forgiveness—the gap between supply and demand will persist, threatening universal health coverage goals.

Expert Perspectives: Professionalization, Accountability, and the Path Forward

Scholars and practitioners emphasize that KEMU's fee structure is a double-edged sword: essential for maintaining

training quality but a potential barrier to inclusivity. Dr. Funmi Adeyemi, a nurse educator at Obafemi Awolowo University, argues: 'Fees fund simulation labs, clinical placements, and faculty development—critical for producing competent nurses. But if they exclude the poor, we risk creating a professional class disconnected from the communities it serves.' The Nigerian Nursing Council's 2022 report echoes this, warning that opaque fee-setting undermines public trust. Internally, KEMU has initiated reforms: a transparent fee committee with student and faculty representation, real-time fee publication, and a scholarship algorithm prioritizing rural and female applicants. Yet critics note that implementation remains inconsistent, with delays in fee announcements and uneven scholarship distribution. Economist Dr. Chike Okonkwo of the African Development Bank highlights: 'Nigeria's failure to standardize nursing fees nationally perpetuates inefficiency and inequity. A centralized framework—with regional adjustments—could balance affordability and sustainability.'
