The analysis didn't just document corruption; it quantified the structural vulnerabilities that enabled it—highlighting how fragmented oversight, weak audit mechanisms, and opaque bidding processes collectively produced systemic risk. This investigation triggered regional policy reforms, including the digitization of procurement platforms and the creation of independent oversight nodes modeled on Bhavikatti's diagnostic frameworks. It also signaled a shift: investigative journalism was no longer confined to exposing individual malfeasance, but to diagnosing the institutional pathologies that make abuse possible. By 2020, with the rise of AI and predictive analytics, Bhavikatti's work had matured into a hybrid discipline—part journalism, part computational social science. His team developed proprietary software capable of real-time structural inference, using machine learning to simulate the consequences of policy changes, regulatory shifts, or leadership transitions. In a 2021 report on energy sector reforms in Southeast Asia, this tool projected how deregulation would concentrate market power in a few oligopolistic firms, enabling rent-seeking and undermining competition. Together, they developed a “structural vulnerability index”—a composite metric assessing how susceptible institutions are to capture, manipulation, or collapse based on network topology, data transparency, and oversight density. Applied to media houses, regulatory bodies, and financial institutions, the index reveals hidden fragilities long invisible to auditors and journalists alike. Yet not all reception has been uncritical. Some institutional economists have questioned whether structural models risk oversimplification, reducing human agency to network dynamics. When power sees its own fragility, it responds.”

In Europe, investigative units like France’s **Mediapart** or Germany’s **Netzwerk Recherche** emphasize legal rigor and public interest litigation. While philosophically aligned, they often operate within formal legal frameworks. Bhavikatti, by contrast, builds tools that function outside traditional legal boundaries—using open-source intelligence, graph analytics, and predictive modeling to generate actionable intelligence even
