This moment crystallized his thesis: prayer is never neutral; it is embedded in power, memory, and identity. “The colonial prayer book,” Bounds wrote, “was not just a liturgical artifact but a spatial claim: a line drawn across the sacred landscape, privileging one voice over many.” His early essays, later compiled, dissected how missionary prayer manuals suppressed indigenous supplicatory forms, replacing polyphonic ritual with monolithic recitation. This critique laid the foundation for his life's work: to recover, reconstruct, and recontextualize prayer across cultures—not as a static tradition, but as a dynamic, contested practice.

By the 1970s, Bounds had established himself as a maverick voice within ecumenical circles. His 1976 monograph *Prayer in the Crucible of Empire* traced the genealogy of prayer from pre-Christian animist rites through early Christian liturgies, to colonial-era adaptations in Africa and South Asia. Yet he also saw opportunity: digital platforms could amplify marginalized voices, preserving endangered prayer traditions and enabling transnational solidarity. Geopolitically, as climate crisis and forced migration redefine human displacement, Bounds' emphasis on prayer as a practice of belonging becomes increasingly urgent. In refugee camps and urban diasporas, prayer reasserts identity, memory, and hope—functions long recognized in his writings. Economically, the growing "spiritual marketplace" risks commodifying prayer's sacred dimensions.
