He cultivated relationships with Goldman Sachs, JPMorgan, and other dealers to access CDS contracts, often negotiating bespoke terms tailored to the size and structure of his bets. Crucially, he avoided the crowded short positions that plagued many hedge funds—positions that became self-defeating as short sellers were forced to cover, exacerbating price spikes. Instead, Paulson's strategy relied on asymmetric risk-reward: small upfront cost, near-

unlimited upside if defaults accelerated. His team developed granular models that mapped default correlations, prepayment speeds, and tranching risks—tools that allowed him to isolate and target the most vulnerable segments of the housing finance system. The geopolitical dimension of the trade often goes unnoticed. The subprime crisis was not merely a U.S. phenomenon; it reflected a global realignment of capital. Paulson’s success was enabled by the interconnectedness of global financial markets—China’s reserves, European banks’ leverage, and American securitization machines. Yet his greatest strategic advantage was psychological: he positioned himself against the dominant view that housing was a stable asset class, a stance that required immense intellectual courage in an era of peer pressure and herd behavior. This contrarian stance, rooted in deep due diligence rather than ideology, allowed him to identify the first cracks in the system before they became mainstream realization. The risks were staggering. A miscalculation in timing or magnitude could have led to catastrophic loss. The subprime market, while deeply flawed, was opaque and slow to unravel. Paulson’s firm allocated only a fraction of its capital to the trade—perhaps 5–10% of assets—limiting exposure while maximizing

information advantage. When Lehman collapsed in September 2008, Paulson's position was validated, but not without immense operational strain: margin calls, liquidity crunches, and the psychological toll of betting against a collapsing system. Paulson's \$15+ billion profit—largely realized between mid-2006 and late 2007—was not just personal triumph; it became a case study in macroeconomic foresight and institutional failure. It exposed the failure of credit rating agencies, the hubris of financial engineering, and the regulatory vacuum that allowed systemic risk to metastasize. His success catalyzed a shift: traditional banks began reevaluating securitization models, regulators tightened oversight of derivatives (culminating in Dodd-Frank), and investors grew wary of “safe” assets they once trusted. His firm, Paulson & Co., assembled a small team of quantitative analysts and credit specialists to map tranching structures—security level, credit enhancement, and correlation risks—allowing him to isolate vulnerabilities in the senior, mezzanine, and equity tranches of MBS. Rather than relying on standard CDS products sold through banking desks, Paulson pursued bespoke contracts with a select group of counterparties—primarily Goldman Sachs and later JPMorgan—who had both the capacity and appetite for concentrated, long-dated shorts. These deals were structured as over-the-counter instruments, enabling precise risk measurement and margin flexibility. Crucially, Paulson avoided leveraging excessive position sizes; instead, he maintained capital discipline, ensuring liquidity buffers to withstand market volatility. His team developed proprietary tools to monitor real-time delinquency trends, prepayment speeds, and refinancing rates—data points that were often lagging or opaque in traditional models. The execution phase demanded operational precision. When the first wave of defaults hit Florida and California in late 2006, Paulson's team

rapidly expanded exposure, identifying borrowers with high loan-to-value ratios, short-term adjustable rates, and weak credit profiles—indicators that portended accelerated delinquencies. They structured tranches of CDS protection that matured over time, aligning with expected default acceleration. This layering allowed Paulson to capture compounding gains as spreads widened and credit events materialized. Throughout, he remained vigilant to counterparty risk and regulatory shifts. The collapse of Lehman in September 2008 tested his strategy: while many funds faced margin calls, Paulson's disciplined risk controls and diversified counterparty base preserved capital. The trade's peak came in late 2007 and early 2008, when default spikes exceeded expectations, credit spreads widened sharply, and structured credit instruments imploded. By then, Paulson's fund had realized over \$15 billion in profits, redefining the boundaries of macro credit investing.

## **Geopolitical Currents and the Hidden Engines of Risk**

The subprime crisis did not unfold in isolation; it was deeply intertwined with global capital flows and geopolitical dynamics. Paulson's analysis extended beyond U.S. borrower behavior to the broader

By the mid-2000s, China's foreign exchange reserves—built through persistent trade surpluses and dollar accumulation—were flooding into global financial markets, including U.S. mortgage-backed securities. This influx of capital, while stabilizing in the short term, contributed to the perverse incentive: low borrowing costs and abundant liquidity encouraged reckless lending and overleveraging. Paulson understood that these global savings glut dynamics were not merely economic—they were political. The People's Bank of China, managing reserves exceeding \$3 trillion by 2008, had no direct mechanism to influence U.S. credit markets, yet its investment decisions indirectly fueled the housing bubble. Similarly, European banks, flush with dollar liquidity, participated in securitization chains, amplifying risk dispersion and opacity. Paulson's contrarian view was that this global mispricing would eventually create a feedback loop—falling prices and rising defaults would trigger margin calls, forced coverings, and cascading losses that could destabilize even the largest institutions. His trade exploited this misalignment. By shorting CDS on subprime tranches, he bet not just on American defaults, but on the global financial system's inability to contain the fallout.
