The Army expanded its physical therapy corps, instituting multidisciplinary teams that combined manual therapy, neuromuscular re-education, and early mobility protocols. rehabilitation to integrated, multidisciplinary care. The Army Physical Therapy Program responded by embedding therapists within combat support units, enabling near-immediate intervention.
