The novel’s portrayal of BDSM—while framed as consensual and reciprocal—sparked fierce debate among sexologists and activists. Experts like Dr. Esther Roth, a clinical psychologist specializing in paraphilic behaviors, cautioned against conflating fictional dramatization with real-world practice. ‘The fantasy,’ she argued in a 2014 interview with **The Guardian**, ‘is not a blueprint.
