In response, initiatives like the U.S. CHIPS and Science Act and the EU's Critical Raw Materials Act now include pharmaceutical ingredients under strategic supply chain safeguards. Reshoring efforts, particularly in the U.S. and Europe, aim to rebuild domestic CMC capacity, though they face steep barriers: high capital costs, skilled labor shortages, and entrenched global competition. Equally significant is the role of emerging economies in shaping CMC governance. Countries like Brazil and South Africa advocate for technology transfer and local manufacturing sovereignty, pushing for inclusive access to patented knowledge. Meanwhile, African nations remain heavily dependent on imports, raising ethical questions about equity in global health.
