This model proved resilient, allowing the company to serve not only U.S. public schools but expanding markets in Latin America, Southeast Asia, and Europe, where Western educational models were often adopted or adapted as part of modernization programs. The globalization of Sadlier’s worksheets reveals a deeper geopolitical and economic story.
