A 2024 report by the International Labour Organization documented cases in Nigeria and India where children were paid \$1–\$3/day, subjected to 12-hour shifts, and denied rest—all under the guise of “training” and “digital literacy.” These systems are not accidental. They are designed to externalize risk, maximize flexibility, and minimize liability. The legal architecture—dominated by private contracts, trade agreements, and weak international labor standards—enables this calculus. These children work 10–12 hours daily, earn less than \$1/day, and often miss school. Multinational chocolate brands, while signing commitment pacts, rarely verify compliance due to opaque sourcing. The result: certification systems fail to deliver protection, and children remain trapped in cycles of poverty. The tech industry's child exploitation is equally insidious. AI training data relies on millions of unpaid, often underage annotators. In Kenya, Nigeria, and the Philippines, children are recruited via social media or informal networks, paying nominal fees to access “digital literacy” programs that mask labor. A 2024 ProPublica exposé found that workers in Dhaka and Manila face psychological distress, with many reporting anxiety, depression, and burnout. These workers, mostly aged 14–18, are monitored via

software that tracks keystrokes and screen time, reinforcing behavioral control. The data they generate fuels models that exploit attention—including that of children—creating a feedback loop of harm. The fashion industry mirrors this pattern. Experts warn that piecemeal solutions are insufficient.
