The Fractured Mirror: Robert Solomon and the Existential Condition in a Post-Metaphysical Age

From the ashes of two world wars, from the accelerating mechanization of human life and the collapse of traditional moral frameworks, existentialism emerged not as a philosophy but as a cultural grammar—one that articulated the dissonance between inherited meaning and lived experience. At the heart of this intellectual tempest stood Robert Solomon (1927–2009), a Jewish-American philosopher whose work transcended academic boundaries to become a visceral meditation on what it means to be human in an age stripped of certainties.
