In Africa, the 'Jesus' as healer overlaps with 'Jesus' as deliverer, but 'Give Me Jesus' redirects focus from miracles to transformation of character. Looking forward, the long-term implications are profound. As secularism deepens in the West, spiritual movements like 'Give Me Jesus' may evolve into hybrid forms—less denominational, more experiential, more decentralized. Blockchain-enabled faith communities, AI-driven spiritual coaching, and immersive VR worship could integrate its surrender ethos into new technologies. Yet the core challenge remains: how to sustain depth amid digital fragmentation, and how to balance personal devotion with collective responsibility. Lotz's legacy, then, is not just a book or a movement, but a lens through which to view the evolving human quest for meaning.
