divine lineage but also through the symbolic elevation of stature as a reflection of heroic destiny. A 2023 report by

Grand View Research estimated the global anti-aging and height optimization market at \$12.7 billion, with projected CAGR of 11.4% through 2030. This growth is fueled not by medicine alone, but by a cultural ecosystem: social media influencers, wellness entrepreneurs, and corporate diversity programs that subtly reinforce height as a symbol of ambition and presence.
