Southern Europe's post-Franco Spain and post-Mouammar Gaddafi Libya share transitional trauma, yet Spain's success stemmed from a negotiated amnesty, inclusive dialogue, and phased reform. In contrast, Venezuela's democratic collapse—despite electoral

rituals—exemplifies how economic mismanagement, institutional decay, and external interference can dismantle formal democracy without overt violence. These divergent paths underscore that consolidation is not inevitable; it is the outcome of deliberate, context-sensitive choices. Long-term implications hinge on three axes: generational change, institutional adaptability, and global solidarity. Younger generations in democracies—more educated, digitally connected, and socially progressive—are reshaping political engagement, demanding climate action, racial justice, and economic fairness.
