The original Donaldson Press editions, while groundbreaking for a female lead, often depicted marginalized communities through a narrow, paternalistic lens. Scholars like Dr. Kwame Adebayo have documented how early narratives reinforced stereotypes—immigrant neighborhoods portrayed as dangerous, Black characters underrepresented or tokenized.
