The Milwaukee Family Council, representing siblings and relatives of Dahmer’s victims, has publicly denounced online forums using the term, calling it “a grotesque perversion of justice.” Supporters counter that such critique misunderstands the purpose: the honor society, in this context, is not about Dahmer, but about systemic accountability. It invites analysis of how society neglects signs of distress, how institutions fail marginalized communities, and how media shapes collective memory. For some, the “honor” is not to the man, but to the memory of those erased—ensuring their stories are not reduced to sensational headlines. Legal scholars note additional layers: while no entity is officially sanctioned, the use of Dahmer’s name in such contexts walks a fine line. Looking ahead, the Jeffery Dahmer Honor Society—however paradoxical its name—reflects structural shifts in how societies
