This delayed recognition underscores a critical truth: Mendel’s insight depended not only on genius but on a convergence of technological readiness, institutional receptivity, and theoretical alignment that simply did not exist in his era. The allele, as Mendel conceptualized it, was not a molecular entity but a statistical abstraction—a probabilistic mediator of trait transmission.
