Simultaneously, urban reformers in Europe and North America began applying spatial reasoning to public health and urban planning. The 1854 Broad Street cholera outbreak in London, famously analyzed by John Snow, marked a watershed: by mapping disease cases, Snow demonstrated that illness clustered around a contaminated water pump, introducing spatial causality as a diagnostic principle. This event, though not explicitly labeled “locational analysis” at the time, planted the seed for using location as a vector of causation and intervention.

The Evolution: From Fieldwork to Satellite Imagery

The 20th century catalyzed a methodological revolution.
