Amid this chaos, a coalition formed under the Global Digital Workforce Alliance (GDWA), uniting multinational corporations, labor unions, and public policy bodies. Led by Dr. Lila Chen, a labor systems theorist formerly with the International Labour Organization, the group prioritized inclusivity, transparency, and adaptability. Their foundational insight: that remote work competencies could not be reduced to checklists, but required layered, context-sensitive assessment. The first iteration of the RBT framework, released in late 2022, focused on six core

But challenges emerged: inconsistent digital access hindered participation in video-based assessments, and language barriers affected scoring accuracy. These early hurdles informed subsequent iterations, driving the inclusion of multimodal assessment formats—text, audio, code submissions—and multilingual scoring protocols.
