Farben pioneered process optimization through empirical rule-of-thumb scaling, but as operations grew more complex, reliance on intuition gave way to dimensional reasoning. Engineers began applying the Buckingham Pi Theorem (1916), which formalizes dimensional reduction by identifying dimensionless groups—enabling generalized models across different scales. This was revolutionary: a reaction kinetics model derived in a 10-liter reactor could be scaled to a 10,000-liter vessel if the dimensionless Damkohler number remained constant. Yet this transition was neither technical nor purely scientific. It unfolded within a geopolitical and economic context defined by industrial nationalism and resource competition.
