In contrast, Japan’s approach, rooted in **shinrin** (precision medicine) and lifelong learning, emphasizes continuous skill refinement through annual competency reassessment, aligning with the Lewis Guide’s longitudinal tracking but extending it across decades of practice. Meanwhile, China’s National Health Commission adopted a modified Lewis framework in 2016, adapting its modular structure to address regional disparities in surgical access, though implementation remains uneven across urban and rural provinces.
