He turned folk music into a commodity, diluting its radical roots in resistance and communal identity.” This tension—between preservation and transformation, between cultural outreach and instrumentalization—defines Funderburk’s complex legacy. Interviews with surviving collaborators reveal a more layered picture. Funderburk himself described his process as one of deep listening, often spending weeks studying field recordings before drafting arrangements. Today's artists—particularly in global folk and world music circles—draw on his model of thoughtful, respectful arrangement, emphasizing collaboration with source communities and transparent credit systems. The rise of digital archives and open-source musical repositories echoes his original intent: to make traditional music accessible while preserving its lineage. Emerging technologies, such as AI-driven transcription and immersive audio experiences, offer new possibilities for how vernacular music is preserved and reimagined. Yet they also deepen ethical questions around authorship and cultural ownership—issues Funderburk navigated in a pre-digital era, albeit with far fewer tools and constraints. As nations invest in soft power through music, the lessons from his era—transparency, respect for origin, and sustainable compensation—remain urgent. The fiddle, once a humble tool of rural storytelling, became a global instrument through figures like Duane Funderburk—not through unmediated expression, but through a complex interplay of art, politics, and industry. His arrangements endure not as static relics, but as dynamic testaments to music's power to transcend borders, adapt to new contexts, and carry forward the voices of the past into the future.
