Controversies surrounding Haddix’s case have simmered for decades, surfacing most intensely in the 2010s during investigative journalism probes into Cold War-era child programs. The 2014 exposé by **The European Tribune** revealed that her adoption papers had been altered in 1978 by a Frankfurt notary with ties to U.S. Army intelligence, citing “national security concerns.” This revelation ignited legal battles: Haddix, now in her early 60s, attempted to reclaim her original identity through judicial channels in Germany and Switzerland, only to face procedural barriers and diplomatic resistance. This was not an oversight but a design feature. The U.S. military's Joint Task Force "Harmony," active in West Germany from 1965–1972, maintained a shadow dossier system for children under 12 deemed "geopolitically sensitive"—those born to mixed-heritage mothers from Eastern Europe, the Middle East, or Latin America. These children were systematically separated from biological families, enrolled in state-run institutions, and later funneled into private care networks with military contracts. Haddix's placement in such a system—first in Frankfurt, then Geneva,
