The humanitarian toll was obscured by geopolitical maneuvering: Russia's military intervention, Iran's regional ambitions, Turkey's border security doctrine,

and Western powers’ strategic disengagement. In this vacuum, information became a battleground. State media, rebel broadcasts, and international outlets competed not only for attention, but for legitimacy—each shaping narratives that served political ends. Amina’s notebook arrived at a critical inflection point. Traditional journalism, constrained by access limitations, embedded reporting restrictions, and the commodification of trauma through sensationalism, often reduced Syria’s crisis to statistics and soundbites. Human rights organizations documented atrocities, but their reports were filtered through legal and bureaucratic lenses, distancing readers from lived experience.
