Her analysis, grounded in a decade of clinical data, counters critics by emphasizing outcome metrics: a 2023 state audit found NP-managed diabetes patients had HbA1c levels within target range 12% more often than those under physician-only care. Conversely, Dr. Alan Pierce, a family physician and medic for the NCMS, warns of unintended consequences. "Autonomy without adequate oversight creates accountability gaps," he contends. "We've seen cases where NP-patient relationships lack continuity, and prescribing patterns reveal regional inconsistencies—sometimes too aggressive, sometimes overly cautious." These concerns have spurred calls for a state-level NP registry and standardized continuing education mandates, currently being debated in Raleigh. Ethical and regulatory risks remain salient. The North Carolina Board of Nursing has intensified scrutiny of prescribing practices, particularly in pain management, where NP-led clinics reported a 30% spike in opioid prescriptions between 2018 and 2021—double the national average.
