Principais Tipos de Exercícios de Porcentagem

1. Cálculo de porcentagem de um valor

2. Cálculo do valor total a partir de uma porcentagem

Envolve calcular o valor final após um aumento ou desconto baseado em porcentagem.

5. Problemas de juros simples e compostos

Aplicados principalmente em finanças, esses problemas envolvem calcular juros e valores finais após aplicação de porcentagens de juros.

Exercícios Resolvidos de Porcentagem Matemática

Exercício 1: Cálculo de porcentagem de um valor

Questão: Qual é 15% de R\$ 200? Resolução: Para encontrar 15% de R\$ 200: $15\% \times 200 = \frac{15}{100} \times 200 = 0,15 \times 200 = R\$ 30$ Resposta: R\$ 30

Exercício 2: Valor total a partir de uma porcentagem

Questão: Um produto está com 20% de desconto e seu preço final é R\$ 160. Qual era o preço original? Resolução: Sabemos que o valor final corresponde a 80% do preço original (pois $100\% - 20\% = 80\%$). Vamos chamar o preço original de P . $80\% \times P = R\$ 160$ $\frac{80}{100} \times P = 160$ $0,80 \times P = 160$ $P = \frac{160}{0,80} = R\$ 200$ Resposta: O preço original era R\$ 200.

Exercício 3: Encontrar a porcentagem de uma parte em relação ao todo

Questão: Uma turma tem 30 alunos, dos quais 9 são meninas. Qual a porcentagem de meninas na turma? Resolução: $\text{Porcentagem de meninas} = \frac{9}{30} \times 100 = 0,3 \times 100 = 30\%$ Resposta: 30% dos alunos são meninas.

Exercício 4: Aumento percentual

Questão: O salário de um funcionário era R\$ 2.000 e foi aumentado em 10%. Qual será o novo salário? Resolução: $\text{Aumento} = 10\% \times 2000 = \frac{10}{100} \times 2000 = R\$ 200$ $\text{Novo salário} = 2000 + 200 = R\$ 2200$ Resposta: O novo salário será R\$ 2.200.

Exercício 5: Desconto percentual

Questão: Uma loja oferece 25% de desconto em um eletrônico cujo preço original é R\$ 1.200. Qual será o preço com desconto? Resolução: $\text{Valor do desconto} = 25\% \times 1200 = \frac{25}{100} \times 1200 = R\$ 300$ $\text{Preço com desconto} = 1200 - 300 = R\$ 900$ Resposta: O preço com desconto será R\$ 900.

Resolução de Problemas Mais Complexos

Exercício 6: Problema de porcentagem com múltiplos passos

Questão: Uma loja vende um produto com um preço de R\$ 500. Ela oferece um desconto de 10% e, após o desconto, há um acréscimo de 5% de imposto sobre o valor final. Qual o valor final que o cliente pagará? Resolução: Passo 1: Calcular o desconto de 10%: $10\% \times 500 = 0,10 \times 500 = R\$ 50$ Preço após desconto: $500 - 50 = R\$ 450$ Passo 2: Calcular o imposto de 5% sobre o valor com desconto: $5\% \times 450 = 0,05 \times 450 = R\$ 22,50$ Valor final a pagar: $450 + 22,50 = R\$ 472,50$ Resposta: O cliente pagará R\$ 472,50.

Exercício 7: Juros simples

Questão: Uma pessoa investe R\$ 1.000 a uma taxa de juros simples de 12% ao ano. Qual será o valor total após 3 anos? Resolução: Cálculo do juros total: $J = P \times i \times t$ onde: $P = R\$ 1.000$ $i = 12\% = 0,12$ $t = 3$ anos $J = 1000 \times 0,12 \times 3 = R\$ 360$ Valor total após 3 anos: $V = P + J = 1000 + 360 = R\$ 1.360$ Resposta: Após 3 anos, o investimento valerá R\$ 1.360.

2. Desconto: 15%

Desconto = Preço original x Percentual de desconto

$$\text{Desconto} = \text{R\$ } 200,00 \times 0,15 = \text{R\$ } 30,00$$

$$\text{Preço final} = \text{Preço original} - \text{Desconto}$$

$$\text{Preço final} = \text{R\$ } 200,00 - \text{R\$ } 30,00 = \text{R\$ } 170,00$$

Resposta: O preço final do produto após o desconto será R\$ 170,00.

Exercício 2: Aumento de salário

Enunciado:

Um funcionário recebeu um aumento de 12% em seu salário, que era inicialmente R\$ 2.500,00. Qual será o novo salário?

Solução passo a passo:

Passo 1: Informações dadas

1. Salário inicial: R\$ 2.500,00
2. Percentual de aumento: 12%

Passo 2: Converter o percentual em decimal

$$12\% = 0,12$$

Passo 3: Calcular o valor do aumento

$$\text{Aumento} = \text{R\$ } 2.500,00 \times 0,12 = \text{R\$ } 300,00$$

Passo 4: Calcular o novo salário

$$\text{Novo salário} = \text{Salário inicial} + \text{aumento}$$

$$\text{Novo salário} = \text{R\$ } 2.500,00 + \text{R\$ } 300,00 = \text{R\$ } 2.800,00$$

Resposta: O novo salário do funcionário será R\$ 2.800,00.

Exercício 3: Problema de proporção

Enunciado:

Em uma aula, 30% dos alunos são mulheres. Se há 24 mulheres na turma, qual é o total de alunos?

Solução passo a passo:

Passo 1: Dados

1. Porcentagem de mulheres: 30%
2. Número de mulheres: 24

Passo 2: Converter porcentagem em decimal

$$30\% = 0,30$$

Passo 3: Montar uma regra de três

Se 30% corresponde a 24 mulheres, então 100% corresponde ao total de alunos (x):

$$0,30 \times x = 24$$

$$x = 24 / 0,30$$

$$x = 80$$

Resposta: O total de alunos na turma é 80.

Dicas para aprimorar a resolução de exercícios de porcentagem
