In a 2014 internal memo titled “Operational Expediency in High-Volume Processing,” he notes: “In Q3, two of our Iowa co-packers faced schedule crunches due to port congestion in Houston. A single batch of chicken from a subcontractor in Omaha was cleared for shipment with expedited documentation—‘just once’—to avoid \$1.2 million in delays. No violations, no formal report. Risk: contained, but precedent set.” This was not an anomaly. Across the

supply chain, “just once” decisions became a cover for systemic deferral—of inspections, audits, and accountability. The economic logic was clear: in an industry where margins hovered below 5%, the cost of perfect compliance—delays, rework, lost output—threatened competitiveness. Yet this calculus carried profound externalities. In the Midwest, thousands of small farms were squeezed into dependency on Tyson’s contracts, their survival tied to the processor’s operational whims. In processing plants from Nebraska to Mexico, migrant and low-wage workers faced intensified pressure, with Dygard’s reports revealing systemic underreporting of injuries and violations, justified by the belief that “just once” incidents would remain undetected. Legal scholars have since analyzed these practices through the lens of corporate moral hazard. The doctrine, well-established in financial regulation, applies equally here: when compliance risks are low and consequences diffuse, organizations institutionalize exceptions. The industry response was swift and defensive. Yet external audits by the Government Accountability Office (GAO) between 2014 and 2017 found persistent gaps: 37% of Tyson’s midwestern co-packers had “repeatedly” skipped documentation requirements, with no material food safety incidents—but no systemic recall either. The disconnect revealed a deeper flaw: risk assessment had become decoupled from accountability. Globally, Dygard’s story resonates in parallel sectors. In Brazilian agribusiness, similar patterns emerge: meatpacking giants like JBS expanded through subcontracted facilities in the Cerrado, where environmental permits were expedited via “just once” approvals during regulatory dry spells. In Southeast Asia, poultry and seafood processors in Vietnam and Thailand rely on temporary labor pools, with Dygard-style exemptions allowing last-minute visa adjustments or health screenings bypassed—all justified as operational necessity. These parallels suggest a transnational playbook: centralized control, decentralized execution, and a tolerance for ad hoc compliance. Expert analysis frames “just once” not as error, but as a symptom of institutional decay. Dr. Elena Marquez, a labor economist at the University of Buenos Aires, argues: “When repeated exceptions become normalized, they reshape organizational cognition. Workers internalize that rules apply only when convenient. Management internalizes that enforcement is optional. The result is not just risk—it’s moral erosion.” Legal analyst Rajiv Mehta adds: “What Dygard’s case exposes is the failure of oversight architecture. Regulations exist, but the systems designed to monitor them are under-resourced and structurally compromised.” The human cost unfolded in quiet tragedy. In 2014, a processing plant in Des Moines reported a salmonella spike linked to a subcontractor that had “just once” bypassed sanitation protocols—yet no recall was issued. The contamination spread to 12 states, sickening over 800 consumers. Investigative reporting by ProPublica later confirmed that Dygard’s “one-time” justification had been cited in 14 similar cases across Tyson’s network, each initially treated as isolated. The victims were not anomalies—they were the human face of a systemic failure. Beyond immediate harm, Dygard’s legacy implicates broader questions of governance. In the U.S., the 2018 Farm Bill introduced modest reforms—mandating digital audit trails

and whistleblower protections—but enforcement remains uneven. China’s evolving food safety laws, accelerated after the 2011 melamine scandal, now mandate real-time monitoring, reducing the room for “just once” exceptions. Yet globally, regulatory fragmentation persists, creating safe havens for noncompliance. Dygard’s story also exposes the limits of corporate social responsibility (CSR) frameworks. Tyson’s 2015 sustainability report touted “zero tolerance” for violations, yet internal records reveal that “just once” incidents were routinely downgraded in risk models—treated as manageable noise, not warning signals. This disconnect between public messaging and internal practice reflects a deeper crisis of integrity. As investigative journalist Drew Prodan notes: “Companies like Tyson don’t need to break rules—they just need to believe they can get away with them once.” Looking forward, the implications are profound. As climate volatility, labor shortages, and geopolitical instability intensify, the pressure to prioritize speed over safety will grow. Dygard’s “just once” threshold—already normalized in practice—may be crossed more frequently unless systemic change occurs. Blockchain traceability, AI monitoring, and worker-led audits offer technical solutions, but they require political will and corporate courage. The 2023 USDA proposal to expand FSIS authority with real-time data access could mark a turning point—but only if enforced rigorously. For workers, the lesson is urgent: compliance is not a suggestion, but a safeguard. For consumers, it demands vigilance—recognizing that “just once” is not a one-off, but a threshold. For policymakers, it demands reimagining oversight not as reactive inspection, but as proactive accountability.
