They operated under layers of anonymity, cultivating relationships with insiders across sectors: former bankers fluent in code, intelligence analysts disillusioned with state secrecy, and whistleblowers risking asylum. In 2012, their investigation into the offshore financial hub of Jersey—codenamed “Operation Midnight Sun”—exposed how multinational corporations, including major tech firms, used complex trust structures to evade over \$30 billion in tax liabilities annually. The series, supported by encrypted data from a whistleblower within a major audit firm, prompted the OECD to accelerate the Base Erosion and Profit Shifting (BEPS) initiative, now a cornerstone of global tax transparency. But their rise was not without peril. In 2014, Griffin survived an assassination attempt in Belgrade, where she was targeted for publishing evidence linking Serbian oligarchs to a 2006 coup destabilized by Western intelligence. The attack, attributed to a network with ties to former intelligence operatives, underscored the physical costs of their work. Piker, targeted two years later in Pittsburgh during a break-in at their office—likely orchestrated by individuals connected to the very financial system they had exposed—endured a year-long legal battle before recovering. These incidents were not isolated; they reflected a broader pattern of retaliation against investigative outlets that

challenge entrenched power. Their institutional resilience became a case study in risk mitigation. *Global Lens* pioneered secure communication protocols, decentralized data storage, and a “fire brigade” response team trained in crisis management. They also pioneered a hybrid funding model—combining reader donations, foundation grants, and limited corporate sponsorships—designed to insulate editorial independence. This model, now emulated by outlets like *ProPublica* and *OCCRP*, challenged the myth that quality journalism requires corporate patronage. The geopolitical context of their work evolved dramatically over two decades. In the early 2000s, the focus was on state corruption and post-conflict accountability.
