Critics, including leading psychologists and critical legal scholars, challenge its purported neutrality. The test's normative sample, though expanded, remains anchored in U.S. demographics—predominantly White, middle-class, urban populations. Forensic and clinical experts further caution against overreliance. Future Trajectories: Integration, Regulation, and Ethical Reckoning
