The 2021 Tallinn Manual 2.0 clarified that cyber operations causing “death, injury, or significant disruption” could trigger collective defense—but only if state actors were implicated. The Erebus Collective, however, operated through encrypted diaspora networks, using proxy nodes in Eastern Europe and West Africa, blurring attribution. France, long a bridge between NATO and EU digital policy, found itself caught between upholding alliance cohesion and preserving its own covert operational flexibility. The incident also exposed fractures in the transatlantic response to critical infrastructure. While the U.S. pushed for rapid, coordinated sanctions and intelligence sharing, countries like Italy and the Netherlands resisted, fearing escalation.
