Born in the drought-prone hinterlands of Maharashtra, Manjari's trajectory was shaped not by privilege but by the visceral

reality of villages where water vanished, land was swallowed, and futures folded in on themselves. His early years were spent in a family that lived not in the margins of development but in its violent periphery—where displacement was not an anomaly but a seasonal inevitability. In response, Manjari insists: "The marginalized are not passive victims. They resist, organize, and reimagine their futures. My job is to document the terrain of struggle, not to romanticize it." His work challenges the global North's narrative of "emerging economies" by exposing the violence inscribed within growth. As climate migration accelerates—India is projected to displace 140 million by 2050—his frameworks for understanding displacement as a political, not just environmental, phenomenon will grow vital.
