It is not a one-size-fits-all template but a dynamic, evolving companion that adapts to legal, religious, and personal contexts. Organizations like the Open End-of-Life Initiative (OEOL) in the Netherlands and the End of Life Choice Project in Australia have integrated its framework into public education campaigns, citing measurable improvements in patient-provider communication and reduced family conflict. Yet the workbook's ascent is not without controversy. Critics argue that removing professional guidance risks misinterpretation, especially in complex cases involving cognitive decline, cultural differences, or terminal illness. There is concern that “free” tools may be co-opted by commercial entities offering premium add-ons, diluting their egalitarian intent.
