The Franco-Prussian War (1870–1871) left France economically weakened, its cultural institutions strained. Meanwhile, the Austro-Hungarian Empire and Russian Tsarist regime suppressed artistic dissent, pushing creative innovation underground or into exile. Van Gogh, though Dutch, was acutely aware of this

pan-European ferment. His exposure to German Romanticism—through composers like Wagner and Schumann—imbued his aesthetic with a tragic grandeur. Wagner's **Tristan und Isolde**, with its unresolved harmonies and emotional extremity, mirrored Van Gogh's own unresolved inner conflict.
