The crisis exposed a fundamental tension: a single codebase serving a fragmented, heterogeneous user base could not simultaneously guarantee pixel-perfect consistency across geographies, devices, and network conditions. Geopolitical and Economic Undercurrents The problem was not confined to technical shortcomings; it was entangled with global power dynamics in digital infrastructure. In Western markets, users assumed cloud platforms offered uniform quality—Microsoft, as a U.S.-based giant, symbolized technological leadership.
