This professionalization, while enhancing transparency, also introduced bureaucratic friction. Grassroots workers report increased administrative burden, with time spent on paperwork detracting from direct service. A

2022 internal survey by Caritas Italy found that 63% of field staff felt “disconnected from the original purpose” due to worksheet rigidity. Yet organizational leaders counter that such structures are necessary to sustain donor trust and operational legitimacy in an era of heightened scrutiny.
