"When compliance inspectors face pressure from political elites or agribusiness lobbies," Trapence observes, "the system becomes a façade rather than a safeguard." Conversely, Dr. Agnes Mphatso, a compliance specialist at the University of Malawi's Centre for Agricultural Research, argues that JCE has quietly evolved into a more responsive institution. She points to recent efforts to digitize certification processes, train inspectors in risk-based auditing, and engage farmer cooperatives in compliance education. "JCE is no longer just about enforcement," she explains. "It's about building capacity—helping smallholders understand standards before they even plant. This preventive approach reduces rejections and builds trust." Human rights advocates, however, raise deeper concerns. Organizations like Human Rights Watch have documented cases where JCE inspections led to abrupt farm closures or seizure of crops without adequate due process, disproportionately affecting women farmers who manage smaller plots. "Compliance must not become a tool of exclusion," warns Amina Kachale, a Malawian civil society leader.
