This cross-cultural friction underscores the limitations of a U.S.-centric vocabulary in assessing international talent. Industry experts highlight a growing tension between standardized academic language and authentic expression. Cognitive scientists and educational psychologists warn that over-reliance on formulaic expressions—“I’ve developed a growth mindset,” “my research process involved iterative feedback”—can mask genuine intellectual curiosity. These “performance words,” while aligned with institutional expectations, may incentivize performative writing rather than authentic reflection. Psychologist Dr. Lila Chen observes: “When students internalize the vocabulary of success, they risk conflating linguistic fluency with intellectual depth. From a sociolinguistic lens, linguist Dr. Carolyn Stein highlights the danger of “lexical gatekeeping”—the use of specialized academic language as a proxy for potential, without acknowledging linguistic diversity. She calls for “translational pedagogy,” where institutions bridge home languages and academic discourse, enabling students to develop fluency in both. “When a student’s dialect is dismissed as unacademic,” Stein argues, “we lose not just expression, but identity.”
