CARI became a living laboratory, testing adaptive technologies in real-world clinical settings while training students in both human-centered and machine-augmented therapy. The center's work on telerehabilitation—accelerated by the COVID-19 pandemic—demonstrated that virtual care could maintain therapeutic efficacy, particularly for rural populations with limited access to specialists. Their leadership reoriented the curriculum toward clinical outcomes, evidence-based interventions, and interprofessional collaboration. Industry Impact: Reshaping Rehabilitation Through Innovation and Integration

Briar Cliff's physical therapy program has catalyzed systemic change across the rehabilitation industry, particularly in clinical practice models, technology adoption, and workforce development. For instance, students now calibrate robotic-assisted walking devices to individual biomechanics, adjusting resistance and support in real time based on patient feedback. This adaptive training mirrors clinical practice, where therapists customize interventions using real-time data. Such methods have reduced recovery times by up to 30% in pilot studies, a metric that has influenced national competency standards. Equally significant is the program's role in workforce innovation. Briar Cliff's curriculum includes a 'clinical innovation lab,' where students collaborate with engineers and data scientists to prototype assistive devices.
