Meanwhile, tech ethicist Dr. Kate Crawford highlights the storm's digital dimension: AI, surveillance, and data monopolies are redefining power. “We are building systems that amplify bias, manipulate behavior, and concentrate control,” she warns. “The storm is not just environmental or economic—it is existential for autonomy itself.” These voices,
